The NORTH CAROLINA LAW ENFORCEMENT OFFICERS ASSOCIATION is offering cash scholarships to eligible students who are currently enrolled or who have been accepted into an accredited college or university to study criminal justice-related courses.

ELIGIBILITY REQUIREMENTS

To be eligible for consideration, the student must:

1. Be a member or the immediate family member (son, step-son, daughter, step-daughter or spouse) of a member of the North Carolina Law Enforcement Officers Association in good standing for past two years.
2. The student must be enrolled in a Criminal Justice or Criminal Justice related course of study in an accredited college, university or technical school.
3. Provide transcript with minimum GPA of 3.0 and also provide ACT or SAT scores if applicable.
4. Provide a list of hobbies, outside interests or extra-curricular activities the student is involved in. List any volunteer work participated in.
5. The student must be engaged in or seeking a full-time career in detention, corrections, law enforcement, law or another criminal justice-related field.
6. The student may be required to appear for a personal interview before the Scholarship Committee.

TO APPLY

The student must complete a scholarship application and forward it (along with all required information) to the NC Law Enforcement Officers Association Scholarship Committee. The packet must be mailed to the following address and postmarked on or before March 1.
